To reunite D11 in fighting for a city that works for all in a Just Recovery centered around the economic needs of everyday people and essential workers.

---

Why do you want the League of Pissed Off Voters' endorsement?

The San Francisco League of Pissed Off Voters puts out an accessible, well-researched, and independent voter guide that deconstructs candidates and issues on the public record, offering multiple perspectives in their political analysis. The League guide does not simply tell voters how to cast their ballots but educates them with critical context on how to consider candidates and issues as they vote. I cannot think of a more trusted voter guide nor a guide that so many voters literally reach out to in their decision-making.

## What are your values and how did you get them?

Everyday, I am moving towards a more revolutionary form of activism that seeks to overthrow the pathological system of capitalism for a worker controlled government and economic system that puts human need over corporate greed. I come from the working class. I am Chicano. My mother and father were born in the US during the Great Depression at a time of great Jim Crow-type discrimination against Mexicans in the U.S. Southwest. My parents first language was Spanish. My mom, a brilliant and compassionate woman, had to work to increase household income rather than pursue an education and career. My father was a longshore worker who spent 40 years working the docks of Los Angeles. We lived in Wilmington, a part of LA literally surrounded by oil refineries, power plants, waste treatment facilities, the port of LA, networks of freeways and railway tracks, and over policing. Wilmington, was not a safe place to live. My father occasionally got injured on the job and I witnessed several industrial accidents over the years that gave me a sense of how our economic system subjects working people to constant harm and our communities to poison and deprivation.

I grew up in a Catholic school run by Irish nuns who on occasion taught a strand of a compassionate, Franciscan ideology that somehow sunk in. For 5th grade, I had a radical humanist, Catholic teacher who introduced guitar masses and whose lessons somehow got past the school censors. She showed us films on the Vietnam War war protests, the impact of the Atomic bomb on the people of Hiroshima and Nagasaki, the Nazi Holocaust of the Jewish people, and many films on the Civil Rights struggle.

In 1974, my parents divorced and in 1976, my mom remarried and our entire family moved to a small, white, New England town in Massachusetts. I faced shitty discrimination and racialized treatment that ranged from "playful" putdowns to outright blatant abuse and limits on my opportunities. I grew up with anger and embarrassment in my heart.

After graduating from high school, I fled back to CA and fought for years in college, work, and social work school to build my confidence, a process that was not complete until I understood that my sense of agency comes from the people.

I have always considered myself as part of the movement for social justice.

What communities do you represent and how do they hold you accountable?

I am grounded by my community ties. D11 is home to everyday working people of all ethnicities but primarily white, Latinx, API and Black. We don't have many multi-millionaires let alone any billionaires in D11. We are mostly homeowner households but at least 20% of our homes have in law units so that D11 "single family homeowners" are also landlords too. While in office, I worked to choose projects with my constituents and to build power through organizing campaigns to win on our issues. Every year, we worked on budget advocacy all across the district.

Since leaving office in 2016, I went back into direct organizing in the labor movement with the National Union of Healthcare Workers. With NUHW, I worked to build the collective power of hospital workers, neighborhood clinic workers, and mental health clinicians. I am directly accountable to these workers. As the Avalos 2020 campaign moves forward we are building a co-governance structure to choose issues and hold me accountable to my votes and good behavior. I need this structure because it is easy to lose your way and let your ego drive you in the world of cutthroat politics where the community cannot always be by your side. But we are learning and I am finding my footing every day.

What do you think is the best way to address San Francisco's culture of political corruption?

San Francisco has a serious problem with pay to play politics and the politicization of City services and resources. I had hoped that the Public Advocate would make it to the ballot. It didn't and allowing the existing watchdog, whistleblower, and investigatory functions in the City Attorney, District Attorney, Controller, HR, and other departments to continue to play these functions when they have failed so miserably is tantamount to looking the other way. I will continue to push for the Public Advocate. In the meantime, I will use the power of inquiry of the Board of Supervisors to hold hearings and to examine how our city is working to identify and ferret out corruption. I will use my office as a bully pulpit to exhort the City to do more with greater rigor to identify and root out corruption and pay to play politics. I am interested in creating oversight bodies over the Mayor's Office of Housing and Community Development, the Office of Economic and Workforce Development, and as needed with all City departments. We have to put the people of the City and County of San Francisco first.

In the midst of a homelessness crisis, how can the City and County of San Francisco improve the effectiveness of our city's homelessness and supportive housing services?

The City has essentially created containment zones for unhoused people in parts of D10, the D9 and D6. These concentrations of homeless people come from the City's main modus operandi of shuffling people from sidewalk to sidewalk and block to block. I have been a proponent of the continuum of care to provide a range of services along a spectrum that ranges from supportive housing, rental subsidies, employment services, family unification services, healthcare, and behavioral healthcare, etc.

The pandemic has exacerbated homelessness in D11. As Supervisor, I will work to create a drop in center with nutrition, medical care, mental healthcare and behavioral health services, and showers. Before going on leave, I represented workers at a drop in center in the Mission. I support the use of state funds to repurpose hotels and housing facilities in my District for housing homeless people. I support a navigation center in D11, navigation centers are much more preferable to people sleeping on the sidewalks, in doorways and in the parking lots.

Lastly, I do not support the forced removal of people encamped on our sidewalks without there being a place for them to be moved to that offers access to nutrition, shelter, and showers for their dignity and selfcare.

How would you expand checks and balances in regard to mayoral appointments?

I support the Board of Supervisors, vetting each and every candidate for boards and commissions and in fact believe appointments should be split evenly between the Mayor and Board of Supervisors. I wrote "Let's Elect Our Elected Officials" to take away the Mayor's ability to fill vacancies on the SF Board of Supervisors. The appointments actually taint our elections and rarely work in the Mayor's favor but end up dividing voters along lines that limit substantive discourse in elections.

Would you propose any rezoning or other policy changes to increase housing -- particularly affordable housing -- while protecting against the displacement of current residents?

Yes, only for 100% affordable housing.

If you're elected, what racial justice policies will you push for?

I am counting on Proposition 16 passing on the California ballot. Prop 16 would repeal the state's ban on affirmative action programs and the use of information related to race and gender in hiring, access and admission to public institutions. If Prop 16 passes, I would rigorously pursue the hiring of people of color and women in our public services and examine the barriers to hiring that exist in our HR department and city departments.

I would work closely with the Office of Racial Equity and work to put stronger standards in place for ensuring equitable investment for parks, transit, health and human services, housing in San Francisco's communities of color.
