### **COVID Response**

When the pandemic hit, your society was at the forefront, engaging with elected officials at all levels of government. We participated in weekly discussions with the Governor's office, our Congressional delegation, and our local legislators. We signed on to letters to our elected leaders urging support for our medical practitioners and the patients they serve. We continue to help direct members to business and financial resources for their practices. And finally, we are closely monitoring the state vaccination distribution plan and are helping members navigate the process.

#### **Legislative Wins**

Although the 2020 legislature was almost completely COVID-dominated by the end of session, we still experienced many successes for our members and your practices, including:

- Telemedicine parity
- Prior authorization transparency
- **Physician Assistant practice changes**, including delegation agreements, physician/PA ratios, and the removal of remote site restrictions.

Our TMCMS trustee Dr. Eddy Cates brought the issue of health care provider credentialing to his 22nd Legislative District delegation. Sponsored by Representative Laurie Dolan, this bill requires insurance carriers in certain circumstances to retroactively reimburse for services delivered to patients during the credentialing process. Due in part to the effort of your local medical society, this bill passed and went into effect on March 17.
