CRITERIA

- ◆ TWU Local 234 members are eligible.
- ◆ Family members must attend school full time to be eligible.
- ◆ Attendance at private high school, accredited college, community college, university or trade school.
- ◆ Proof of eligibility must be forwarded to the Union Hall by the deadline.

REQUIRED DOCUMENTS

- ◆ Roster and/or Class Schedule with student ID #, name of school and address.
