Announcement – Vacancy – UBCIC Vice-President Position
Nominations from the floor of UBCIC Chiefs Council June 17th (9:45 am)
Election June 17th (11:30-12:30)
Musqueam Community Centre, x^wməθk^wəy^əm (Musqueam Territory)

UBCIC received notice that Vice-President Robert Chamberlin is resigning from his position as Vice-President of the UBCIC effective immediately. A notice was sent out to UBCIC membership earlier today.

Under the UBCIC bylaws, an election to fill this role for the remainder of the term must be held by secret ballot at the next Chiefs' Council, which is scheduled for June 17th- June 19th, 2019 at the Musqueam Community Centre, x^wməθk^wəy^əm (Musqueam Territory)(6735 Salish Dr, Vancouver, BC). Nominations for the position of Vice-President will be taken from the floor of the Chiefs' Council on June 17th at 9:45 am. The nominations must be supported by at least two Full or Active Members in good standing. The election will occur by secret ballot from 11:30-12:30. The term will expire at the February 27-28, 2020 UBCIC Chiefs Council.

VII. VACANCIES OF EXECUTIVE COMMITTEE AND ACTIVE MEMBER REPRESENTATIVES

- (a) In the event that a member of the Executive Committee or an Active Member is unable to act; resigns; is recalled; or, in the case of the Vice-President or Secretary-Treasurer, ceases to be the representative of a Full Member, the position shall be filled by a simple majority vote (50% of all votes, plus one) of all Full and Active Members in good standing present at an election by secret ballot to be held at the next Chiefs' Council.
- (b) The newly elected Executive Member or Active Member will serve a term concurrent with the remainder of the term of the Member that they are replacing.
- (c) Nominations for the vacant Executive Council or Active Member position will be taken on the floor of the Chiefs' Council meeting, and must be supported by at least two Full or Active Members in good standing.
