Motion Title: CA1 IHRA definition of antisemitism

What's the idea?

The International Holocaust Remembrance Alliance working definition of antisemitism is used by the overwhelming majority of the Jewish community to define contemporary antisemitism. The adoption of this definition by UJS was also adopted overwhelmingly at UJS Conference in 2016.

Over the past year, Jewish people's self-definition of antisemitism has seen unprecedented attacks. Both inside and outside of student spaces, non-Jewish students have sought to block the IHRA definition. UJS must be clear and active in our response that anything other than the definition of antisemitism that we choose for ourselves is inadequate.

How do you want it to happen?

- 1) UJS to reaffirm adoption of the IHRA definition.
- 2) UJS to actively campaign for Students Unions and Universities to adopt the IHRA definition, in collaboration with individual J-Socs.
- 3) Where appropriate, UJS should lobby other local, national or international bodies to adopt the IHRA definition.
- 4) Ensure that the IHRA definition of antisemitism is not used to shut down legitimate criticism of the Israeli government.
- 5) Adopt the position that the IHRA definition is not complete without all its examples.

Motion Title: CA2 UJS should campaign for a Graduate Tax

What's the idea?

1. UJS is currently mandated to campaign for free education.
2. Free Education would mean the entire society would be forced to pay for the few to have university education. This would mean a person who has not been to university paying so others can attend. Even though graduates have a higher average income than non -graduates.
3. Free education would allow less students the opportunity to continue their study to higher education.
4. Free education would cost billions of pounds which could be better spent to support important public services such as the NHS.
5. A graduate tax allows for the best of both worlds. A graduate tax would mean any student can study without the worries of debt.
6. Graduates would start paying the costs of their university tuition when they start earning. This would mean only those gaining from university education would pay for it.

How do you want it to happen?

- 1) UJS should no longer support the free higher education model
- 2) UJS should actively campaign for a graduate tax system to replace the current tuition fee system
- 3) UJS should educate students on the benefits of a graduate tax over free education
- 4) UJS should release a statement announcing support for this policy.

Motion Title: CA3 Free Education

What's the idea?

1. That education is a public good and access to education is a fundamental human right,

enshrined in Protocol 1, Article 2 of the Human Rights Act (1998) which states that:

“No person shall be denied a right to an education.”

2. The Talmud expresses support for free, fair and accessible education on the principle that

taxation of the richest in the community is what should fund Jewish learning also a key

element of Jewish values and beliefs tzedakah advocates such a system.

3. The government is increasingly marketising higher education through further raises to tuition fees, increasing the political weight given to flawed surveys such as the NSS and using the language of “consumers” to talk about students.

How do you want it to happen?

- 1) UJS should make the case for free education and demand that free, accessible, quality education, and decent wages, public services and benefits, are funded by:
 - a. Ending tax evasion and avoidance and cracking down on tax havens,
 - b. Imposing serious taxes on the incomes, inheritance and capital gains of the rich.
 - c. Taking the banks, and their wealth, under democratic control.
- 2) UJS shall use its position on the Board of Deputies to lobby for support from the Jewish community for free education. This could include but should not be restricted to submitting policy to the board for support of free education.
- 3) UJS shall conduct research and produce work on how the principle of how tzedakah and campaigning for free, fair and accessible education is key to Jewish values and the Jewish



community at large. UJS should post at least 2 social media posts or website blogs this year about free education.

- 4) UJS should campaign in favour of free education motions submitted on a national scale at NUS conferences.
- 5) UJS should oppose all efforts to further marketise higher education, including but not limited to fee increases.

Motion Title: CA4 Combating antisemitism in NUS

What's the idea?

- There is a history of antisemitism within NUS with Jewish members of NEC receiving abuse for years due to their Jewish identity. Famously Luciana Berger, now an MP, was forced resign over this.
- The Home Affairs Select Committee report on Antisemitism in the UK, published in 2016, said the then NUS President's language "smacked of outright racism" after calling Birmingham University "a Zionist outpost".
- NUS have, to their credit, adopted the IHRA definition of antisemitism.
- Antisemitism is still a problem in the student movement today, with an NUS NEC member resigning in September 2018 after comparing Israeli policies to those of the Nazis.
- NUS has a firm stance as an anti-racist movement, and also claims to have a 'zero-tolerance' to antisemitism, but the organisation has often failed to put their words into action.
- NUS' Code of Conduct is not fit for purpose for a 'zero-tolerance' stance on antisemitism, as it only covers full time staff or volunteers at NUS events. Therefore, if a non-paid elected representative of NUS posts an antisemitic statement online, which violates NUS' own definition of antisemitism, this is permitted under NUS code of conduct.
- For the NUS Code of Conduct to be fit for purpose, it is imperative NUS update their code of conduct to include the actions of NUS volunteers outside of NUS events.
- It is likely that if UJS had not in the past put significant pressure on NUS, antisemitism would not have been dealt with in a satisfactory manner. Such pressure includes advocating for the adoption of the IHRA definition at NUS conference in 2017. Before this, NUS had used the EUMC working definition since 2000.

How do you want it to happen?

1. Mandate UJS to fight antisemitism within NUS and the wider student movement.



2. Mandate UJS to put pressure on NUS to update their Code of Conduct to include the actions of NUS volunteers outside of NUS events.
3. For UJS to continue to work with those in the student movement who stand with Jewish students against antisemitism.

Motion Title: CA5 Strengthening UJS' commitment to fighting hate speech on campus

What's the idea?

On campus it is understood that there are many groups that can cause students to feel uneasy or uncomfortable. There are some groups though which directly threaten to physically harm innocent students and UJS should always ensure it works with the relevant organisations to ensure they are allowed no presence in campus life.

The NUS has set clear guidelines on what organisations should be no platformed and this allows for stronger mobilization against these abhorrent groups.

UJS should stand side by side with NUS in strongly enforcing this policy to ensure the continued physical wellbeing of students simply trying to attain an education.

Last year at conference a policy was passed which was far too broad in defining hate, stating that UJS should not be associated with organisations who "hold extremist beliefs, a far-right ideology, homophobic attitude are racist or discriminatory based on religious grounds". Loose language will not help us tackle the roots of hatred and could potentially lead to divisive partisanship if Labour were to be deemed 'racist' or the Conservatives were labelled 'far-right'.

How do you want it to happen?

To ensure there are clear guidelines on what UJS defines as hateful or extremist organisations, UJS should repeal the overly broad item 1 of motion CA6 (2017) and use NUS's no platforming policy to dictate the organisations it defines as hateful. The policy includes the following organisations:

Al-Muhajiroun;

British National Party;

English Defence League;

Hizb-ut-Tahrir;

Muslim Public Affairs Committee.

National Action

UJS should work closely with NUS and continue to lead by example by not associating itself with these any of these extremist, hateful organisations.

UJS will renew its commitment to combating hate and continue its work in tandem with other organisations to ensure the future success of this policy

Motion title: CA6 Simplifying UJS Reimbursement Policy

Whats the idea?

Currently UJS is unable and unwilling to directly reimburse external organisations which fund specific events on campus which support Jewish life and Israel engagement.

This is inherently problematic as not every J-Soc has its own bank account. This means that monies must travel through personal bank accounts and already financially stretched students have to pay out large sums before agonisingly waiting reimbursement.

UJS has consistently taken too long to reimburse both individuals and J-Soc's especially considering their financial situation. This desperately need to be improved as a matter of urgency.

With money travelling through personal accounts it is only a matter of time before a serious complaint of potential embezzlement takes place which would undermine both the integrity of the individual and all parties involved. UJS should move to act now instead of waiting for a serious issue to take place

How do you want it to happen?

UJS and its partners will commit to reimbursing external organisations directly supplying that the appropriate J-Soc representative has given explicit permission for this to take place.

UJS must take supportive measures more accessible for those who require extra support in offsetting expenses such as seeking measures to speed up the reimbursement process.

UJS will commit to helping every J-Soc around the country setting up accounts where money can be held (understanding certain SU's have policies about external funding and accounts) to ensure no single individual should be forced to spend personal money.



UJS will support treasurers with personalized training in accordance to the size of their J-Soc. This will happen at the start of their term of office and could be via a webinar, a group training or a meeting/ phone call with the finance department of UJS.

Motion Title: UJ1 Nakba Education

What's the idea?

1. This year marked the 70th anniversary since the Nakba. Many Jewish students do not know what it is, despite having a great deal of knowledge about the history of the State of Israel. No resolution or coexistence can come as long as Jews benefit from Israel's existence while living in ignorance of how it came about.
2. All students, Zionist or not, benefit from a greater understanding of the situation in which the modern State of Israel was born.
3. The Nakba this year will fall on 15 May 2019, a week after Yom Haatzmaut. Nakba day marks when 700,000 Palestinians fled or were expelled from their land, and hundreds of Palestinian towns were destroyed or depopulated

How do you want it to happen?

1. UJS should mark the Nakba by organising educational events, inviting Palestinian speakers (for example refugees) to UJS and J-Soc events to teach about the history of the Nakba.
2. UJS should make a social media post on Nakba Day 2019 about the Nakba, for example featuring a blog post written by a Palestinian.
3. On UJS trips to the State of Israel participants should be informed about the pre-Nakba name of the cities and villages visited, using the Nakba Map provided by Zochrot.

Motion Title: UJ2 Free Speech on Campus

What's the idea?

1. BDS- Boycotts, Divestment and Sanctions- is a non-violent call for action supported by Palestinian civil society. The three demands of the BDS movement are: An end of the Israeli occupation of the West Bank, Gaza and the Golan Heights and dismantle the wall that separates Israel proper and the West Bank, Recognizing the fundamental rights of the Arab-Palestinian citizens of Israel to full equality, Respecting, protecting and promoting the rights of Palestinian refugees to return to their homes and properties.
2. The right of return for Palestinian refugees is a complicated and emotional issue. A physical resettlement of Palestinians to their original properties is literally impossible, and for the majority of BDS supporters not desirable. However, the human right of Palestinians to return to homes which many still have the keys to should be recognised. The BDS movement does not take a position on how the right of return should be enacted.
3. Support for the BDS movement does not necessitate a belief that Jews should be removed from their homes in Israel.
4. Israel Apartheid Week is a yearly event that aims to 'raise awareness of Israel's apartheid system over the Palestinian people and to build support for BDS'.
5. People living in the West Bank are subject to two different legal systems according to their ethnic background. This situation could reasonably be called apartheid. There are also reasonable criticisms of referring to the State of Israel as an apartheid state. This discussion should not be shut down on grounds of antisemitism.
6. Many events that promote the BDS movement have been cancelled on the grounds they are antisemitic, including at UCLAN and UCL.
7. The Board of Deputies have lobbied University Vice Chancellors to cancel events that support BDS and promote 'Israel Apartheid Week'.
8. Some Jews view the BDS movement as antisemitic. Some Palestinians see the cancellation of events promoting BDS as racist and Islamophobic.
9. Sometimes those who support BDS are antisemites, or use antisemitic tropes when advocating for Palestinian rights. However, the BDS movement is not

inherently antisemitic.

10. With the exception of groups or individuals who have been no platformed, free speech on campus should be protected.

How do you want it to happen?

1. UJS should adopt the position that BDS is a non-violent tactic which is not inherently antisemitic.

This does not mean UJS cannot take positions critiquing BDS on other grounds.

2. UJS should continue to call out examples where pro-Palestinian activism does cross a line into antisemitism.
3. UJS should not support any lobbying of universities to cancel Israel Apartheid Weeks, and should make their opposition to this activity known to the Board of Deputies. Any training UJS provides about antisemitism should recognise people's rights to support the BDS movement.

Motion Title: UJ3 J-Socs to collect and donate sanitary products

What's the idea?

- Period poverty stops women getting an education.

How do you want it to happen?

1. UJS owned and Hillel House, or other Jewish centres of Student life will be offered permanent sanitary product collection points.
2. Each collection point will have a designated 'officer': the social action officer on J-Soc where appropriate or another committee member if not.
3. They will be in contact with charity Bloody Good Period who will support the people running the collection points.
4. All sanitary products will be donated to Bloody Good Period with information by the donation point for those who may be affected by period poverty.

How do you want it to happen?

1. Move the liberation networks to a peer-led structure
2. Ensure that the strategy and direction of UJS Liberation Conference is in consultation with students who define in the relevant liberation group

Motion Title: UJ6 Two State Solution Policy

What's the idea?

The Israeli-Palestinian conflict is still on-going over 70 years after the establishment of the State of Israel and is showing no signs of ending.

- It is of utmost importance that peace is achieved between Israel and its neighbours, including the Palestinians.
- The Jewish People have an inalienable right to national self-determination in their historic homeland, which has been exercised in the thriving existence of the State of Israel.
- Palestinian People have an inalienable right to national self-determination.
- The State of Israel must be both Jewish and democratic.
- The only possibility for the State of Israel to remain both a democracy and to uphold its Jewish character, and to finally achieve a lasting and stable peace - for which we all collectively yearn for - is a two State solution in which a sovereign Palestinian state exists alongside the State of Israel.
- This solution, however, is only achievable through a process of negotiation and reconciliation, not through unilateral steps.
- A majority of Jewish Students, as well as a majority of Jews around the world, support the two State Solution as the only resolve to the Israeli-Arab conflict.

How do you want it to happen?

1. UJS to continue to advocate for a two state solution to the Israeli-Palestinian conflict.
2. UJS to continue to work on the ground with groups in Israel and the Palestinian Territories which support the two-state solution on trips.
3. UJS to reaffirm its opposition to BDS.
4. UJS continue to work with organisations in the UK advocating for a two state solution. E.g bringing them to J-Socs.

Motion Title: UJ7 Representation of Sephardi/Mizrahi Jewish Traditions at UJS

What's the idea?

Sepharadi Jews are the oldest Jewish community in the UK and Bevis Marks is the oldest synagogue in continuous use in the UK

The need for better representation of Sepharadi/Mizrahi culture already led to a focus group in 2017

At important events such as the UJS Summit 2018 there was no Sepharadi/Mizrahi service, prayer or tune, although even the Senior Rabbi of the S&P Sephardi Community of the UK was present

Furthermore, UJS does not discuss the inequalities that we face both in the Jewish community and in wider society. It is vital to the health of UJS' cross-communal and representative values that this changes

How do you want it to happen?

1. Make sure Sepharadi/Mizrahi tunes and prayers are included in services at UJS events. If it's an event with more than one service, there can be an Ashkenazi and a Sepharadi/Mizrahi service, either in alteration or simultaneously
2. Wherever possible, include one Sephardi dish at Shabbat meals.
3. Buy non-Ashkenazi siddurim such as Birkat Shelomo or the "Daily and occasional prayers" used by S&P in London
4. Encourage J-Socs to invite Sepharadi/Mizrahi speakers, make services and events inclusive of Sepharadi/Mizrahi traditions, and help J-Socs run events on Sepharadi/Mizrahi traditions
5. Make sure that at UJS events Birkat Hamazon is either sung with an Ashkenazi and a Sepharadi/Mizrahi tune in alternation, or Bendigamos added
6. Run events on Sepharadi/Mizrahi cultures, for example music, films, clothing and food/history/teachings and halakha
7. Commemorate the expulsion of Spanish Jewry and of Jews from Arab Countries
8. Work the Sephardi and Mizrahi groups, such as Spanish and Portuguese synagogues, to make their spaces friendly and accessible to students
9. Include Sephardi and Mizrahi Students in UJS Liberation Networks

Motion Title: UJ10 Our community based on our historical background

What's the idea?

UJS should protect the core historical identity of Jews. This needs to happen in order to get people to participate and engage in conversation to be leaders as students. UJS should acknowledge the hard work we do to build bridges. However, the way it is done at the moment still focuses more on our differences than what we have in common

How do you want it to happen?

1. UJS should remove barriers to look at the faith community from a historical point of view.
2. UJS should make biblical, Talmudic, rabbinic and Kabbalistic sources to be easily accessible to students no matter their level of knowledge, using an online platform.

This would lead to creating a committee to communicate with Jewish courts (communities) across the country to unify with UJS. This should then develop into a committee of 23, lead by the elected President of UJS, to face the problems people outside the jewish community are not facing. The goal is to develop the UJS online platform to facilitate this engagement with our core historical identity, making us all part of the conversation



Motion Title: UJ11 Supporting Jewish students with unique access requirements

What's the idea?

UJS is a democratic space which claims to include all Jewish students in the UK and Ireland. Even though UJS works hard to make this possible, some students need different support than others.

The current structure seems to only facilitate to students who do not have specific access requirements.

This motion wants to support students who have access needs in and around the protective characteristics, no matter whether they are diagnosed or yet to be diagnosed.

UJs should support and enable students who identify with specific access requirements, physical or mental, to ensure they can run and participate to the full extent in UJS activities.

How do you want it to happen?

UJS should have a full-time paid member of staff to encourage and enable students with access needs to participate in UJS opportunities, and be present at events, summits, and conferences etc.

This member of staff should be trained specifically in ADHD and autism support, as well as other access needs.

Motion Title: UJ12 Revoking motion UJ24 (2017)

What's the idea?

1. Object 2.1.5 of UJS's constitution states that the organisation is committed to promoting 'engagement with Israel'
2. Over 90% of UK Jews describe themselves as Zionist.
3. In 2017, UJS Conference passed motion UJ24. This motion dictates that "anti-Zionist viewpoints [must be] represented at all UJS events discussing Israel."
4. Anti-Zionism is the belief that the State of Israel has no right to exist.
5. The IHRA Working Definition of Antisemitism states that "Denying the Jewish people their right to self-determination" can be an example of antisemitic discourse.
6. Motion UJ24, while ostensibly promoting freedom of expression, fundamentally contradicts UJS's historical and constitutional position.
7. UJS should endeavour to include all Jewish students no matter Zionist or not however this should not be done by diluting UJS's support for Zionism.
8. There are many great Zionist Israel engagement organisations from all sides of the spectrum operating on campuses (e.g. stand with us, Yahad) which UJS could work more closely with to create stimulating Israeli engagement events.

How do you want it to happen?

1. UJS should be at the forefront of providing Zionist education on campus.
2. The motion UJ24 from Conference 2017 which called for anti-zionist speakers at UJS events should be removed from active UJS policy.

UJ12 A: Anti-Israel activism (Add Amendment):

1. UJS should commit to not participating in or promoting any forms of anti-Israel activism.

UJ12 B: Anti-Zionist Speaker (Add Amendment):

Proposer: Bradley Langer

1. Anti-Zionist speakers can be included in fair and balanced debates when appropriate.

UJ12 C: Commitment to Zionism (Add Amendment):

Proposer: Bradley Langer

1. UJS will understand “Zionism” to be the Jewish national self-determination in their ancient homeland, the Land of Israel, in accordance with the same right afforded to any other peoples under international law.
2. UJS will work with organisations in the Jewish community to seek wider recognition of this definition.
3. It is perfectly acceptable to question and condemn specific policies of the Israeli government or the government itself, but this does not excuse attacking the internationally proscribed rights of people.
4. UJS should actively work with Zionist Israel engagement organisations from all sides to further the dialogue of students.
5. UJS should use such organisation to train students how to successfully engage with Israel on Campus including having a part of UJS summit devoted to Israel engagement.

Motion Title: UJ13 Clarifying the role of national council

What's the idea?

The role of national council has varied over the years, and UJS Constitution does not make clear exactly how National Council should function. This motion should serve to interpret the constitution and require UJS to facilitate the ability of National Council to perform their constitutional duties.

How do you want it to happen?

1. National Council shall meet regularly with the President, and shall receive regular updates from the President and/or Sabbatical team regarding UJS's activities, to facilitate 7.3.1 of the Constitution.
2. In order to facilitate "scrutinising the decisions made by the President" (7.3.1.1), National Council shall be made aware of any major decisions made by the President.
3. National Council should particularly be made aware of UJS's efforts regarding "social action, liberation, communication, education and inclusivity" (7.3.1.5).
4. In order to "ensur[e] the President upholds the core values of the Union" (7.3.1.3) National Council shall be made aware of any circumstances regarding the President that suggest possible contravention the core values of the Union.
5. "National Council shall meet with the President at least once during an academic term, with a minimum of three meetings during an academic year" (7.3.4) is understood as setting the bare minimum number of National Council meetings to three, and meetings shall take place as frequently as necessary to National Council to fulfil their duties.
6. National Council Meetings may take place in person or via video chat, as appropriate.
7. The Chair of National Council will be given to sufficient ability to publish on UJS's website, either directly or via a member of the UJS team, in order for UJS National Council to "publicise statements after each meeting" (7.3.3).
8. All UJS members shall be made sufficiently aware of what National Council is before the date of National Council elections, so that individuals have



sufficient time, minimally 7 days, to decide to stand, and understanding of what they would be standing for

Motion Title: UJ14 Recognise the value of and uphold the UJS Birthright trips

What's the idea?

1. Birthright trips offer students the opportunity to engage with their Jewish identity in a way that few programs could ever do. It is fundamentally an outreach program; transcending denominational, class, economic status, and gender boundaries.
2. For many students, Birthright is their first time visiting Israel, and for others, Israel is a country they visited many times before, but never in an educational capacity. The program therefore offers a unique opportunity for students to investigate the importance of Israel to their Jewish identity.
3. Given that Zionism is a factor in the vast majority of Jewish Students' identities, students who have not previously been able to should be given the opportunity to experience Israel. The value of birthright must be recognized.

How do you want it to happen?

1. UJS shall commit to continue offering Birthright trips for Jewish students of all backgrounds from across the UK.
2. UJS shall recognise the importance of Birthright trips in allowing Jewish students to explore their identity.

UJS is a democratic organisation and should behave as such, the responsibility for a fair election rests squarely at their feet. Any organisation employed on behalf of UJS must understand this responsibility

An official UJS apology statement should be made to Lawrence Rosenberg regarding the errors made last year during the campaign. These include but are not exclusive to; failing to post his manifesto on time and attempting to cover the mistake up without apology, handing him an incorrect campaign suspension for an incident which occurred years prior to the election and the general failures of organisations in regard to his candidacy. 1. The Motion UJ4, passed at last years conference, proposed the idea that “the choice of organisations to promote [in reference to the peaceful resolution of Israeli-Palestinian conflict] will be made by the UJS President and Campaigns team.”
2. Given that UJS hires campaigns officers, it should be primarily but not exclusively at their discretion to conclude which organisations should be promoted and worked with. The issues addressed in UJ4 fall entirely within the remit of campaigns officers, and decisions should therefore be mostly left to their expertise and experience.
3. Campaigns officers are explicitly hired to make decisions on these issues and the sabbatical team as well as the National Council should be allowed equal input on what organisations they choose to affiliate themselves with.
4. Vitally the language leaves way for the President to infringe on the autonomy of the Campaigns Director to do his/her job appropriately. If a Campaign manager wishes to produce something in cohort with an organisation the President has negative feelings towards, this could lead to potential tension within the sabbatical team

How do you want it to happen?

1. Motion UJ4 shall be amended to give the entire sabbatical team including the National Council input in deciding the choice of organisations that UJS will promote in relation to the Israeli-Palestinian conflict. This is within the obvious limits of conference policy and constitutional requirements.

3. The functioning of these organisations, which service checks and balances on a democratic state are part and parcel of a healthy democracy. They ensure that the government maintains democratic principles such as equality and freedom of expression - principles laid out in the Declaration of Independence as essential components of the Jewish and democratic state of Israel.
4. These organisations are threatened by anti-democratic policies proposed to the Knesset and an increasingly hostile and shrinking democratic space, where those who are supposed to be safeguarding these principles of democracy - members of the Knesset - often publicly express their discriminatory and anti-democratic views and agenda, and speak against these organisations.

How do you want it to happen?

1. These organisations are vital to the continuation of a healthy Israeli democracy. As such, UJS must actively support the existence of these organisations.
2. UJS must reach out to these organisations so that they have a channel to educate British students.
3. This includes programming meetings or activities with these organisations on UJS trips to Israel and doing events with them when representatives are in the UK. Engagement with these organisations is key to understanding how best to support Israeli democracy and legitimate criticism of Israel on campus'

Labour MP Chris Williamson committed a veiled attack on Sheffield J-Soc calling them "opponents of common sense socialism" and "haters" after speaking out against his invitation by Sheffield Labour Students.

How do you want it to happen?

1. Mandate UJS to condemn antisemitism in the Labour Party when it effects students.
2. For UJS to condemn Chris Williamson for his disgusting attack on Sheffield J-Soc.
3. For UJS to continue working with the Jewish Labour Movement, Labour Students, and other allies in the Labour Party who have stood up against antisemitism.
4. For UJS to continue delivering antisemitism training alongside JLM and Labour Students at university Labour Clubs.
5. For UJS to support the efforts of the Board of Deputies and the Jewish Leadership Council to have their Spring 2018 demands met

- 1) On 23rd June 2016, the referendum on EU Membership was narrowly won by the Leave Campaign, however young people, students and the Jewish Community overwhelmingly voted Remain.
- 2) Since the EU referendum result, a number of promises which were made by the official Leave Campaign (members of which have been very senior members of Government during the last two years), have at best been made to have seemed foolish, or at worst outright lies.
- 3) Hate crime increased as a result of the EU referendum and was one of reasons for an increase in antisemitism in 2016 according to CST.
- 4) HM Inspectorate of Constabulary and Fire & Rescue Services has warned of a spike in hate crime around the date of the UK's possible exit of the European Union.
- 5) UJS has a proud history of fighting fascism and racism and defending the Jewish community from the likes of Steve Bannon and Victor Orban - men with clear connections with and lauded by Leave campaigners.
- 6) The antisemitic attacks from Vote Leave on George Soros is another example of the fact that the Brexit process has negative consequences for the Jewish community.
- 7) Prime Minister Theresa May has brought back a deal to Parliament that includes removing support for EU students to study in the UK and the support given to UK students to study in Europe. The deal will also cost £100 billion a year to the UK's economy according to Britain's longest established independent research institute.
- 8) Therefore, if the deal is voted down in Parliament on the 11th December, UJS should stand with Jewish students studying across the EU and the UK, join the fight against the far right and support a People's Vote on the Brexit Deal.

How do you want it to happen?

1. To support efforts by youth and student groups including, but not exclusive to, NUS to lobby Members of Parliament for a public vote on Brexit.



2. To campaign for the rights of EU students in the UK and UK students studying in Europe.
3. To encourage Jewish community voices to support a public vote on Brexit.

Mr Lewis has consistently defended the vulnerable in his professional career, taking on corrupt multinational corporations for clients with little if any resources, and xenophobic commentators such as Katie Hopkins and George Galloway. Mr Lewis was fined by the Solicitors Regulation Authority (SRA) for responding to years of online antisemitic abuse he has faced from neo-Nazis on cyberspace. Nobody in any professional environment or anyone regulated by any institution, including students, should be penalised for standing up to hatred and abuse. Anyone responsible for or complicit in penalising Jews for standing up to antisemitism should be condemned.

How do you want it to happen?

1. UJS passes this symbolic motion in solidarity with Mark Lewis.
2. UJS expresses its deep appreciation and gratitude that Jewish students are able to rely on generous members of the Jewish community like Mark Lewis, who has consistently helped Jewish students pro-bono when facing difficult legal situations in the continuing fight against campus bigotry.
3. UJS expresses its deep concern towards the idea that anyone should be punished for standing up to hatred. The only people who deserve sanction are the abusers and racists, not their victims.
