Discussion: Changes to call to order and attendance to include all committee members at the top and then to show the members present in the call to order. Also, change the spelling of Hammond to Hammons. Director Harada originally moves to approve and open discussion of the item.

Director Hammons moved to approve with changes. Director Harada seconded. Vote was 2 Yay and 1 abstention.

5. Discussion: Head of School/Instructional Leadership Team report

Mr. Castillo shared upcoming dates on the assessment calendar. Third round of NWEA scheduled to start on May 11. This will last for three weeks. The prior week, May 4th we are conducting the SBAC. Results on the SBAC probably won't come back until August similar to the CST/STAR. June 1st we will open a one week window to complete the second round of reading intervention benchmark assessment. These show the reading levels for emerging readers who are not currently at grade level.

Mr. Castillo showed how the data is being disseminated to teachers and for the school using Schoolzilla. This gives teachers classroom data as well as school wide data.

Can we get growth on SCHOOLZILLA by subgroup?

Can we know how to disaggregate the data by students who are below grade level vs who are at or above grade level if they meet their RIT target?

We want to analyze growth based on performance scale. For example, we want to meet expected growth based on performance. This is to assess if we are providing service across all subgroups. We want to see the students in the lowest quartile making 1.5 rit growth.



Is there a way to disaggregate the data by subgroup and by grade through SCHOOL ZILLA?

If we know there are dramatically different patterns in 3/4 by race and socio-economic level then we can compare that to data for k/1 because those students have come into a more normalized school. If the K/1

show the same patterns ad 3-4 then this would show a different problem.

Michael reported there was a data summit in March with the staff and at class level these reports are being made so that the teachers can adjust instruction.

Summer school – in board report. Summer program has received funding. This program is for 40 students and will be free for them and is targeting specific students. This will be a more traditional program. The details are in the report.

SBAC will be used in the renewal process even if we can't use if for school data yet. Questions regarding 1st and 2nd year data were asked. There is some data available but not consistent amongst classrooms.

There was a question regarding enrollment. IS it possible to enroll more TK so that we get the students at a younger age?
