## United Voice Branch Elections 2018

**NOTE:**

1. Nominations open on 18 April 2018 and must reach the relevant Branch Returning Officer as listed on this form at his/her office or postal address, **no later than** 12 noon (Local Time) on Wednesday, 9 May 2018.
2. Nominations cannot be withdrawn after 12 noon (Local Time) on Wednesday, 16 May 2018. In accordance with Rule 40(ja)(ii) withdrawal must be a completed Statutory Declaration by the candidate.
3. Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.
4. No member is eligible to nominate for more than one office on the Branch Executive and/or Branch Council as per the requirements of Rule 40(g).
5. After the close of nominations, where a candidate has nominated for more offices than the rules allow, the Returning Officer will only consider the nomination received last in time. i.e. the last nomination is treated as having withdrawn all the previous nominations. Where the Returning Officer is unable to determine which nomination was received last in time, all nominations will be defected.
6. Candidates for Branch President, Branch Vice-President, Executive Vice-President, Deputy Branch President, Branch Secretary or Branch Assistant Secretary are also required to complete the details at the bottom of this page as per Rule 40(e)(iv).
