### **MISSION STATEMENT**

The mission of the Oklahoma County Sheriff Office's Community Advisory Board (CAB) is to develop and maintain a partnership between the community and the Sheriff's Office. The CAB aims to reduce crime and to enhance the quality of life for all citizens through positive and open communication. The CAB is being created to facilitate interactions between the Sheriff's Office and a committee of diverse citizens, derived from a cross section of citizens within Oklahoma County. The CAB will assist the Oklahoma County Sheriff's Office in establishing the highest standards for accountability with the goal of showcasing the myriad of efforts undertaken by the Sheriff's Office and increasing the public's trust.

### **PURPOSE**

In an effort to strengthen relationships between the Sheriff's Office and community members, the parties created the CAB. The role of the CAB will be to improve communication between citizens and the Oklahoma County Sheriff's Office. The CAB will provide comments and recommendations to the Sheriff on office policies and procedures to ensure best practices are in place and operational.

The philosophy of community policing begins with the Oklahoma County Sheriff's Office providing quality detention services and policing in direct partnership with the citizens they serve. In order to achieve this goal, there must be an open flow of communication, information, and ideas between the community and the Oklahoma County Sheriff's Office.
