## LONG BEACH COUNCILWOMAN LENA GONZALEZ NAMES COUNCILMEMBER REX RICHARDSON AS CAMPAIGN CHAIR FOR STATE SENATE CAMPAIGN

**LONG BEACH, CA** - Today, Councilwoman Lena Gonzalez announced her selection of North Long Beach Councilmember Rex Richardson as her Campaign Chair for State Senate. Councilmember Richardson was elected in 2014 to the Long Beach City Council, serves as a



member of the Southern California Association of Governments and is a leading voice on economic inclusion throughout the region. As Campaign Chair, Richardson will play a critical role in shaping the direction of the campaign through policy, fundraising and community engagement.

We have worked together to fund park programming, affordable housing and creative developments to lift our communities out of poverty and provide equitable opportunities throughout Long Beach. Gonzalez has authored and co-authored over 150 agenda items - more agenda items than any other member of the current City Council. She has championed issues such as creating a citywide Project Labor Agreement, banning Expanded Polystyrene takeout containers and creating workplace protections for truck drivers and hotel workers. She fought to add more park space and programming into underserved parks, created more opportunities for small businesses to participate in city contracts and created the first Digital Inclusion Blueprint in the City of Long Beach to ensure every resident has access to the Internet.



Prior to serving on the City Council, Gonzalez worked with Long Beach Mayor Robert Garcia in his City Council District. Her father was a Teamster truck driver for over 30 years and her mother, who immigrated to the United States at a young age, currently works in technology.
