SUBJECT:	Item 15: Consideration of a resolution to approve a professional services contract with North East Trees to provide field A/E services Parque Dos Rios project.

**RECOMMENDATION:** That the Watershed Conservation Authority Governing Board (WCA) approve a professional services contract with North East Trees to provide field A/E services for Parque Dos Rios for a contract value up to \$62,572.

**PROJECT DESCRIPTION:** A/E Services to support Parque Dos Rios construction of approximately 7 acres of habitat enhancement and a bike stop overlook along the lower LA River bike trail located in the City of South Gate and situated north of Imperial Highway (Exhibit A: Conceptual Plan View).

**BACKGROUND:** North East Trees (NET), a 501(c)3, is the projects Architect of Record for the Construction Documents to construct the improvements that will be implemented under a construction contract with Conservation Corps of Long Beach. NET under this contract for field A/E services will represent the WCA's interests in this project to ensure adherence by the Construction Contractor to delivering a quality project consistent with the approved and permitted Construction Documents. NET's scope will include, but not limited to, responding to Request for Information inquiries by contractor, as-built drawing updates, field direction and drawings as needed, review and approval of submittals, working drawings, structural and civil oversight, project element fabrication buy-off and installation oversight. NET team will include engineering services by sub-consultant of record for the permitted CD plan set. Attendance at kick-off meeting and attendance at weekly construction project that meets design specifications and intent of the project.

NET design services proposal (Exhibit B: Proposal) to provide A/E Field Services for Construction phase of the project. Implementation of the project is funded by a Regional Parks and Open Space District Proposition A Grant to the WCA.

**FISCAL INFORMATION:** NET contract will be funded by the Regional Parks and Open Space District Proposition A grant to WCA to implement the Parque Dos Rios project for a value up to \$62,572.
