



## **2018 Southern California Sexual Health Summit Request for Presentation Proposals**

The Southern California Sexual Health Collaborative, in partnership with Keeping It Real Together, invites individuals or groups to submit proposals for the ninth annual Southern California Sexual Health Summit, to be held on **Tuesday, February 13, 2018 in Los Angeles, California.**

The Southern California Sexual Health Summit is a forum to convene passionate, committed stakeholders from all walks of life and professions whose work focuses on or intersects with the field of sexual health. Representatives from community-based organizations, non-profits, governmental agencies, clinical partners, schools, and the community are encouraged to share the latest information, strategies, and their professional experience as well as develop and foster partnerships for improving sexual health for all across the region.

### **Our goals are to:**

1. Build capacity in Southern California to address the sexual health needs of the region.
2. Leverage interdisciplinary partnerships and share best practices to address the sexual health needs of all Southern Californians.
3. Enhance the quality of comprehensive sexual health education in Southern California by creating opportunities to build provider networks.

### **This year we are particularly interested in presentations that address the topics of:**

- The intersection of social justice and sexual health
- Specific needs of special populations (e.g. youth in foster care, recently migrated youth, youth in group homes, people who are homeless, people of color, people who are incarcerated, LGBTQ+, etc.)
- Fiscal sustainability in an era of funding cuts
- Using social media (or technology) to improve sexual health, raise awareness, and spur action
- The importance of language in sexual health
- Sexuality and differently-abled people
- Sex trafficking
- Communication messaging and strategy (for combating attacks or misinformation, and to reframe the dialog)
- Building, sustaining, and mobilizing coalitions to facilitate and support sexual health interventions
- Youth-leadership (or a youth-led) workshop
- School-based health programs (including California Healthy Youth Act challenges and successes)
- Self-care strategies for practitioners amid intensified demands and challenges in the field

Presentations should be 50 minutes long with 10 minutes for Q&A. All submissions will be reviewed and evaluated by the Planning Committee.

Individuals selected to present will have a free registration spot (max 2) held for the event. Registration information for presenters will be provided with notice of acceptance.
