Led by the Women's Electoral Lobby, Family Planning NSW and Women's Health NSW, the NSW Pro-Choice Alliance represents expert legal, health and community voices from across the state. We are campaigning to remove abortion from the *NSW Crimes Act* and to ensure that abortion is regulated like any other health procedure.

The NSW Pro-Choice Alliance recommends the repeal of sections 82-84 of the *NSW Crimes Act 1900* and the implementation of legislation similar to Queensland's *Termination of Pregnancy Act 2018* and Victoria's *Abortion Law Reform Act 2008*.

We seek changes to the law that:

- Regulate abortion as a health procedure;
- Ensure consistency with contemporary clinical practice, and public health standards;
- Empower women with the right to choose what happens to their own bodies, and guarantee equal access to safe, high quality healthcare, and;
- Align with international human rights obligations.
