Dear Ms. Hershman:

I am the President of the Willow Glen Neighborhood Association and I am in receipt of your letter of January 11, 2021 which requested additional information in connection with our request for reinstatement of our Tax Exempt Status. Specifically, you've requested a copy of our Articles of Incorporation that have been filed with the State of California.

Following our phone conversation of Friday January 15, 2021, I have obtained and enclosed herewith the following and have included the requested declaration. It is my hope that this information along with the previously submitted tax returns and other forms will result in the reinstatement of our Tax Exempt status. The enclosed documents are as follows:

1. A copy of the fully signed and notarized Willow Glen Neighborhood Association Articles of Incorporation (4 pages) with a file date of October 9, 1979.
2. A one page copy of a Certification from the state of California (dated May 22, 2010) confirming that the four page Articles of Incorporation are a true and correct copy of those on file with the State
3. A one page Certification by the State of California reflecting that the Willow Glen Neighborhood Association, # C0963845 dated January 14, 2021 confirming that we are active Domestic Nonprofit Corporation in Good Standing.

ARTICLES OF INCORPORATION

OF

WILLOW GLEN NEIGHBORHOOD ASSOCIATION

I

The name of this corporation shall be Willow Glen Neighborhood Association.

II

The purposes for which this corporation is formed are:

(a) The specific and primary purpose is to improve the Willow Glen neighborhood of San Jose.

(b) The general purposes and powers are to have and exercise all rights and powers conferred on nonprofit corporations under the laws of California, provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation.

III

This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of California. This corporation does not contemplate pecuniary gain or profit to the members thereof and it is organized for nonprofit purposes.

IV

The principal office for the transaction of the business of this corporation is located in the County of Santa Clara, State of California.

V

The general management of the affairs of this corporation shall be under the control, supervision and direction of the board of directors. The names and addresses of persons who are to act in the capacity of directors until the selection of their successors are:

VI

The authorized number and qualifications of members of the corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability to dues and assessments and the method of collection thereof, shall be as set forth in the bylaws.

VII

The property of this corporation is irrevocably dedicated to the charitable and educational purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private individual. Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax exempt status under Section 501 (c) (3)

of the Internal Revenue Code. If this corporation holds any assets in trust, or a corporation is formed for charitable purposes, such assets shall be disposed of in such manner as may be directed by decree of the superior court of the county in which the corporation has its principal office, upon petition therefore by the Attorney General or by a person concerned in the liquidation, in a proceeding to which the Attorney General is a party.

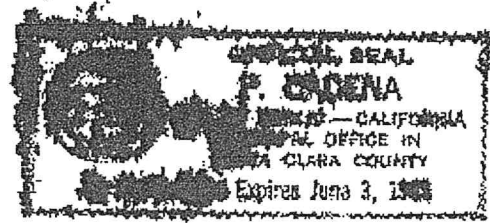
