- 6. The Member will notify the Agent in writing as soon as practicable if the Member ceases to hold at least one ordinary share in the relevant company prior to its 2020 AGM.
- 7. The Agent or the Member can terminate this agreement at any time in writing. However in the event of termination this Agreement will remain valid for any authorised actions relating to the resolutions and supporting statements prior to termination.
- 8. By entering into this Agreement the Member understands that the Agents are acting in their employment, directorship or contractual arrangement with the Colong Foundation for Wilderness Ltd. The Member benefits from the Agent's expertise in seeking to improve the corporate governance of the company or companies. In exchange the Agent supports Colong Foundation for Wilderness Ltd objectives to improve corporate governance of the company or companies.
- 9. The Member acknowledges that the Agent:
