[CARES Act Stimulus checks](#): The Economic Impact Payment, also called a stimulus check, is a one-time cash payment (\$1,200 for most individuals) that the Internal Revenue Service (IRS) will distribute to [eligible individuals and families](#). You can check on the status of your payment and the payment type [here](#). To ensure you get your stimulus check please complete the following steps:

If you filed taxes in 2018 or 2019, or if you receive Social Security, disability (SSDI), Railroad retirement, or survivor benefits you should:

1. **Share Your Direct Deposit Information with the IRS.** Stimulus checks will be distributed primarily via direct deposit. This is the fastest way to receive your check. If you have not shared a direct deposit bank account with the IRS, you can enter your [direct deposit information here](#). If you do not provide a direct deposit bank account number to the IRS, your check will be mailed to the address on file. Note that it may take significantly longer to receive your stimulus check by mail than by direct deposit.
2. [Complete this form](#) if you are a recipient of Social Security, Railroad retirement, or SSDI **AND** you have qualifying children under age 17. The stimulus check will provide an additional \$500 per qualifying child.
3. If the IRS already has your up-to-date direct deposit information, you do not need to take any additional action to receive this money. It will be automatically deposited into your bank account.

If you did not file taxes in 2018 or 2019 you need to:

1. **Complete [this form to request your stimulus check](#) if you did not file taxes in 2018 or 2019.** If your gross income was less than \$12,200 (\$24,400 for married couples), or if you were not required to file a tax return for other reasons, you must complete the request form or you will not receive a stimulus check.

Only people who filed with SSN (and SSN for EVERY person on tax form) are eligible for the stimulus check. Even if just one person on the form used an ITIN, no one will receive (not even SSN holders) will receive the check.

TAXES

[The IRS has extended the federal income tax](#) filing deadline to July 15, 2020. The IRS live phone lines are NOT being staffed. Only self service is available at this time.

[Massachusetts personal income tax](#) filing date has been extended to July 15th.

[Somerville has extended the deadline](#) for the following:

- **Property taxes** that would have been due May 1st are now due June 29 without interest or penalty.
- **Excise taxes** with a due date of March 10th or later are now due June 29 without interest or penalty.

March 27th Update: The president signed the CARES Act into law on Friday, March 27th. AS part of this Act, payments on federally held student loans are suspended until September 30th, 2020. Loans will not accrue interest during this time, and non-payment will not impact credit scores. Note that this benefit only applies to federally held loans, not private loans or loans held by the institution you attended.
