## REQUIREMENTS AND SUBMISSION

### ADOPTION REQUIREMENTS

The adopted equine is owned by the adoptee if the owner upholds to the "Adoption Agreement" (provided at time of adoption), and the "Adoption Requirements" listed below.

- 1) Provide adequate forage (hay and/or grass) and grain to maintain a healthy weight (minimum Body Condition Score 5). No "sweet feed" grain.
- 2) Provide unlimited access to clean water.
- 3) Provide unlimited access to shelter as per Texas Health and Safety Code, Title 10, Chapter 821.021 and Penal Code, Title 9, Chapter 42.09(a)(2).
- 4) Provide medical care as needed including a regular vaccination and worming schedule.
- 5) Provide farrier care as needed. We recommend every 6-8 weeks.
- 6) Provide a permanent, loving home.
- 7) Breeding of any Adopted equine is strictly forbidden unless specified in the Adoption Agreement.
- 8) Pay a non-refundable adoption fee.
- 9) If owner moves adopted equine to any location other than the address listed in the 'Adoption Application', Adoptee will update Wings And Reins of the location of the adopted equine.
- 10) If Adoptee is unable to provide for the adopted equine, as listed above 1 - 9, Adoptee agrees that Wings And Reins can take permanent possession of the equine immediately.
- 11) If Adoptee decides they no longer want the adopted equine, Adoptee agrees to contact Wings And Reins for assistance with placing the adopted equine in a Wings And Reins approved, permanent home or to return the equine to Wings And Reins. The Adoptee agrees that they cannot give the adopted equine to any person, including family members, without permission from Wings And Reins.
