



STREET PARKING PERMITS FOR EMPLOYEES

As of March 25, 2020

The Department of Transportation has assigned a limited number of on-street parking permits to staff. Below is information on how to obtain information on the process.

WHO IS ELIGIBLE?

Priority will be given to front line clinical, clinical support and non-clinical front line staff for use around the facility area.

Temps and affiliates are eligible.

Staff assigned from other facilities are eligible.

PERMITS:

Permits expire July 2020.

It is a felony to duplicate, alter, reproduce or counterfeit the permits.

Those assigned permits will be reported to NYDOT.

Permits are **not** valid in No Standing Anytime, Bus Stops or Ambulance Parking Zones.

HOW TO MAKE A REQUEST?

These NYC parking permits will be authorized, distributed, tracked and retrieved by the designated transportation liaison of each facility. If believe you need a permit, please contact your transportation liaison in your facility by email.
