## ENROLLMENT CHECK LIST

- Determine whether you need Vision Benefits, Dental Benefits or both
- Decide if you need “Single” or “Family” coverage
- If you decide on “Family” be sure to have each dependent’s birth date and SSN
- Use the **2020 RATE BENEFITS** chart to locate your options and the **TOTAL DUE** amount.
- Locate and circle the correct Pay Pal Option listed under the **2020 RATE BENEFITS** chart.
- Log onto [www.wtulocal6.net](http://www.wtulocal6.net)
- Click on the button “ENROLL HERE” in the middle of the WTU web page
- Complete online enrollment and add your dependents ONLINE
- Print the Enrollment Confirmation Page showing your selections.
- Click on the “HOME” icon in the upper left corner of the page.
- Scroll down to the “Option #” that reflects the coverages and cost you selected above.
- Pay for your enrollment by clicking on “PayPal” – as an account holder or guest.
- Enter all required payment information and Print your Pay Pal receipt.

## RATES:

All retirees must sign up to be a member of the WTU Retiree Chapter annually year. Retirees **MUST** pay yearly retiree dues to be eligible for Dental and/or Vision benefits. Membership Dues are: \$ 55.00 / year.

### HOW TO ENROLL - 2020 RETIREE DENTAL and VISION BENEFITS

To receive benefits coverage for the calendar year 2020, you will need to pay the full year's premium during Open Enrollment **November 1, 2019 through November 30, 2019**. You must also be a member of the WTU Retirees' Chapter and pay yearly dues of \$55 to receive benefit coverage. Your new benefit choices are effective starting **January 1, 2020**. Instructions for enrollment are below.

**REMINDER: Checks and Money Order payments are no longer accepted.**

#### ONLINE ENROLLMENT

1. Log onto [www.wtulocal6.net](http://www.wtulocal6.net) & click on the button "ENROLL HERE" in the middle of the page.  
Or go directly to our enrollment site at <https://secure.bswift.com/default.aspx?abbrev=wtu>
2. Enter your username and password.  
Username = first initial of the first name with full last name combined with 2 digits of the month and 2 digits of the day of your birth day.  
Password = last 4 digit of your social security number.
3. Call 202-517-1477 to get your username or password if you do not remember them.
4. If you are retiring for the first time ever this year, click "First Time User" and follow the prompts to enter the company code: **WTU-82556**
5. Remember to save your progress often at the bottom of each page.
7. We are excited to announce our new credit / debit card payment options through PayPal! Retirees may now use our online payment option to remit payment for Retiree chapter membership dues, and dental and vision premiums.
