We have a health crisis in America and in our country! The world must know!

- Of the top 17 most developed countries, the USA is last in health but first in health care costs.
- There has been a 79% increase of Crohn's disease in children in the past 10 yrs.
- 1 out of 2 of USA males and 1 out of 3 females are expected to get cancer today.
- Pesticides are linked to loss of IQ. American IQ has dropped 7 points since GMOs, which increase the ingestion of neurotoxin glyphosate.
- The US infertility rate is 30% in young couples, the highest in recorded history.
- Of the top developed countries, the USA is #1 for infant deaths on the first day of life. 50% more babies die in the US, on the first day of life than all of the industrialized nations combined. -Save the Children Report 2015

If we continue at the current rate:

- 1 out of 2 children born in 2032 will be diagnosed with autism.
- 80% of households with a child with special needs will result in divorce.
- The cost of diabetes alone will bankrupt the US health care budget in 11 years.

The primary reason for these illnesses? **Toxic exposure.**

Many say that the 80,000 chemicals used in our food, products, vaccines and in sprays used in our communities are “safe” because they have been approved by the EPA.

This is simply untrue. These chemical products are not proven safe.

The EPA has failed us and here are some of the reasons why:

1. The EPA's approval policy calls for the manufacturer to submit studies for review showing only the safety of one declared “active” chemical ingredient in a product, NOT the final formulation as used on our food and feed crops.
2. This means that the EPA does not have ANY long term animal studies on any of the final formulations of any chemical product, such as Roundup herbicide, Naled insecticide or other chemical products sitting on the shelf at Home Depot or being sprayed on our food.
3. The EPA does not test the chemicals themselves. They receive studies submitted by the very industry which stands to benefit from them, conducted by scientists from universities who are funded by the chemical companies and the EPA staff are then lobbied and pressured by Senators and Congressmen, who are receiving donations from the chemical companies, to approve these chemicals.
4. The approval of only the one active chemical ingredient completely overlooks the impact of the co formulants or other adjuvants in the chemical product. Many of these adjuvants have been found to be 1000X more toxic.
5. These chemicals have been found in our children's urine, tap water, breast milk, bread, cereal, eggs, milk, beer, wine and even childhood vaccines.
6. The only way to stop the contamination of our children and poisoning of our planet is to discontinue the use of toxic chemicals all together, as they have been found in the air, streams, irrigation water and rain, which can not be controlled.

Solutions:

1. **FOOD:** 80% of the soy used in American organic food is imported! FEED America First! Grow, Buy, Eat and subsidize ORGANIC (non GMO, non toxic) food in schools, hospitals, and communities. Support GMO Free Zones .
2. **WATER:** Support awareness of and use of Reverse Osmosis water systems and filtration to completely remove toxic chemicals. Demand stricter laws to reduce pollution from industry, farming and household use.
3. **INSECTS:** Encourage citizens, Scouts, and community groups to put up bat houses, use electric sappers, beneficial plants and preventative measures.
4. **WEEDS:** Purchase and promote the use of Steam Weed Control ie: Weed Technics safe steam weed control machines, permaculture, soil maintenance and preventative landscaping using local free green waste as mulch.
5. **VACCINES:** Support health choice freedom by advocating for the appeal of SB 277, require safe vaccines, and inform citizens of the presence of toxins currently in vaccines.

The fact is that chemical companies are systematically poisoning our county residents; resulting in increasing healthcare costs, putting a strain our economy, loss of productivity in the workplace, increased insurance costs and rates, decrease of gifted and talented students entering the workforce, increased strain on housing for assisted living, increase of mental illness, addiction, violence and increase of divorce rates, effectively destroying the fabric of our society. We can not be a world power this way! Nearly 700 lawsuits are pending against the manufacturer of Roundup (glyphosate), Monsanto, for causing non Hodgkin's lymphoma. City workers are at risk of harm and county coffers are at risk of depletion by lawsuits.

We cannot afford toxic chemicals in our country! The cost to our children and our future is too great. Please take action to revoke the license of glyphosate, stop GMO chemical farming now and use organic, AgroEcology methods instead.




Figure 14-5. Life Expectancy versus Health Expenditure per Person, Group of Seven Countries, 2012
